It is hereby informed that the following examination regulations will be followed from the academic year 2021-22.

#### **1. Assessment of Students: For students admitted in 2021-22 and thereafter**

##### Weightage for Continuous Internal Assessment (CIA) and University Examinations (UE)

###### UG programmes

- Weightage of Continuous Internal Assessment (CIA): 30%
- Weightage of University Exam (UE): 70%
- Eligibility for a Pass

A minimum of 40% in CIA, 40% in UE and minimum **40% in the aggregate** is required to obtain a Pass grade.

###### PG programmes

- Weightage of Continuous Internal Assessment (CIA): 50%
- Weightage of University Exam (ESE): 50%
- Eligibility for a Pass

A minimum of 50% in CIA, 50% in UE and minimum **50% aggregate** is required to obtain a Pass grade.

#### **2. Photocopy and Revaluation of answer scripts**

1. Applying for Photocopy Revaluation of answer scripts is applicable only for students of all undergraduate programmes.
2. Applying for the Photocopy of the answer scripts is a prerequisite for applying for revaluation of the answer book in the said subject.
3. This photocopy and revaluation facility shall be for **theory papers only**.
4. The revaluation of answer scripts shall not be permitted in respect of the marks awarded to the scripts of practical examination /term work/ seasonal work / project work / dissertation / internal assessment / term work (including theory part) and in viva voce /oral / practical examinations.
5. The prescribed application form for Photocopy and revaluation of answer scripts can be obtained from the Office of Controller of Examinations.
6. If any candidate desires to apply for Photocopy/ photocopies of answer scripts (subject to a maximum of 3 answer scripts), he/she shall apply to the COE through the Programme Director (PD)/ Head of the School (HOS) in the prescribed application form by paying the required fees, within 3 days from the date of publication of results on website, excluding the date of publication of results.

7. The non-refundable prescribed fees of Rs.300/-\* per subject per answer book for the purpose of Photocopy and Rs.300/-\* per subject per answer book for revaluation shall be applicable for photocopy of answer script and revaluation of answer script respectively.
8. The prescribed application form for revaluation of answer scripts duly filled in and signed by the applicant and recommended by the Programme Director is to be submitted to the Office of COE along with the proof of payment of prescribed fees within ten (10) working days from the date of the declaration of the result of the respective examination, excluding the date of publication of results.
9. Incomplete form and form not accompanied by relevant documents will be rejected without assigning any reason whatsoever.
10. The results of revaluation shall be published only after due approval by the respective Result Passing Board.
